

- > TMK developed its Environmental Strategy to 2036
- Six integrated environmental permits were obtained
- A Waste and By-Product Management Program for 2024–2027 was developed and approved
- > TMK enterprises inventoried PCB-containing equipment and updated the relevant transfer-for-disposal schedules for 2025–2027

- > Under the Clean Air federal project, the Company continued retrofitting gas cleaning systems at CHTPZ and upgraded the gas cleaning units in the plasma-cutting area at TMK PS
- > CHTPZ did pre-commissioning of the AQA Balance complex, which treats industrial and storm water at the enterprise

TMK's spending on greening initiatives

- > TMK approved its Low-Carbon Development Strategy to 2036
- > The Greening Program for Enterprises and Regions of Operation for 2024–2027 was developed and approved
- > TMK's Green Initiative, a corporate greening program, was launched, with a series of tree planting events held across the Company's operating regions

- > GHG emission calculations were verified, and an auditor's opinion was obtained
- > The Low-Carbon Energy Transition Framework for TMK Enterprises was developed
- > Activities under the Energy Efficiency Program were implemented across operations

Key highlights

- > Safety Days were held across all production sites, involving 46 thousand Company employees and 4 thousand contractor personnel
- > Seven enterprises, including all TMK Group
- > The rollout of digital safety management tools continued, including the OTPB.Online system, the Incident Investigation Library digital archive, and the Bank of Best Practices
- was launched to review existing processes, methodologies, and tools to strengthen the safety culture

> VTZ, TAGMET, STZ, SinTZ, PNTZ, and CHTPZ are running a large-scale cardiovascular disease prevention program, which focuses on five key areas: medical care, healthy eating, physical activity and fitness, health resort treatment, and awareness-raising

- > The HR Policy was updated
- Engagement surveys were conducted, followed by plans to further improve employee engagement
- > Wages were indexed

- > Under the Effective Mentoring program, 1,300 employees received training. By the end of 2024, TMK had a total of 5,503 mentors
- > The Horizons forum and the Master Games corporate vocational skills competition were held



- > Taxes were paid in full to the federal and regional budgets
- Social and economic partnership agreements between plants and municipal authorities remained in force
- Over 50 initiatives aimed at developing infrastructure in our regions of operation were implemented
- > The first Volunteer Forum was held

- Over 500 volunteer projects were carried out as part of broader efforts to support volunteer engagement
- > Two annual grant competitions were held, providing project-based support for non-profit and public sector organizations and support for local communities
- Industrial tourism projects were implemented at TMK Group enterprises

- > All TMK Group enterprises underwent a corruption risk assessment, which found no significant corruption risks
- > 125 senior managers of the Company took training on anti-trust regulation, which covered, in particular, liability for corruption offenses
