# TMK ships a large batch of premium tubular products to the Yamal LNG project

TMK, one of the world's leading producers of tubular products for the oil and gas industry, has shipped a batch of premium tubular products to Yamal LNG, finalizing the delivery of shipments, contracted for 2016.

TMK has been a supplier of premium tubular products for Yamal LNG (develops the South-Tambeyskoye field in the North-East of the Yamal Peninsula) since 2012. In 2014, TMK signed a contract with Yamal LNG to supply premium tubular products through 2020.

Under this long-term contract, 4,700 tonnes of premium pipe have been shipped to the Yamal Peninsula since the start of the year. The most recent batch included 178 mm, 245 mm, and 324 mm casing pipes with TMK UP PF and TMK UP FMC connections, 114 mm tubing with TMK UP FMT connections, and crossover subs.

Tubular products under this order were manufactured by TAGMET, Seversky Tube Works and Sinarsky Pipe Plant, as well as by TMK NGS-Buzuluk, which is part of TMK Oilfield Services. Experts from TMK-Premium Service will supervise running casing into the wells operated by Yamal LNG.
