TMK joins Earth Hour initiative

On 25 March 2017, TMK, one of the world's leading producers of tubular products for the oil and gas industry, took part in Earth Hour, the world's largest environmental event, for the first time. They switched off the external lighting at their office buildings along with other energy consuming systems not involved in production.

Participation in Earth Hour is one of the key events as part of TMK's Year of the Environment programme.
