## TMK-Kaztrubprom listed as a Samruk-Kazyna Fund qualified supplier

The TMK subsidiary TMK-Kaztrubprom has become one of the first companies in its line of business to become a potential supplier in accordance with the Sovereign Wealth Fund Samruk-Kazyna Procurement management standard after successful completion of the prequalification procedure.

As per the effective rules, prequalification is mandatory for all companies participating in tenders held by Kazakhstani companies under Samruk-Kazyna Fund management, including NAC Kazatomprom, NC KazMunayGas, NC KTZ, and Samruk-Energy.

Auditors from TOO TÜV Rheinland Kazakhstan inspected TMK-Kaztrubprom production facilities, assessed and confirmed compliance of the company's documentation and processes with all the applicable requirements. The audit resulted in TMK-Kaztrubprom being listed as a prequalified potential supplier of most critical products to Samruk-Kazyna fund and its affiliated companies.
